LEPOGO LA THABA / PARTICIPANTS / CAMPERS INDEMNITY FORM

I, _____, ID _____ the undersigned:

A. in my personal capacity as a major adult over the age of 18 years;

B. in my capacity as guardian of my minor child/dependant/family _____, for and on his/her/their behalf ("the Indemnity Grantor"), and pursuant to my/my minor child's/dependant's/family's application to participate in the activities of Lepogo La Thaba:

I am aware that the associated activities that are to be undertaken has inherent dangers, which could result in serious injury.

I hereby acknowledge, agree to the following terms and conditions of operations and indemnity and undertake in favour of, Lepogo La Thaba, its directors, employees, representatives and agents ("the Indemnified Persons") that:

1.1 the Indemnity Grantor is fully aware that the Lepogo La Thaba associated activities are being undertaken at own risk and that the activities may involve hazardous terrain and activities and the Indemnity Grantor fully accepts all the risks associated therewith;

1.2 the Indemnity Grantor hereby releases the Indemnified Persons from all liability and holds each and all of the Indemnified Persons harmless against all claims, damages, injuries, losses, deaths, expenses and liabilities arising out of or in any way connected with participating in the Lepogo La Thaba activities including without limitation:

1.2.1 any personal injury or loss of life;

1.2.2 any loss of support, maintenance or other claims or damages arising from or connected with any personal injury or loss of life to the Indemnity Grantor; and

1.2.3 any loss or damage to clothing or any property belonging to the Indemnity Grantor or any other third party which may occur whilst the Indemnity Grantor is participating in the Lepogo La Thaba activities, whether arising out of strict liability, statute or otherwise and whether caused by the negligence or gross negligence on the part of the Indemnified Persons or any other person or otherwise.

2. The Indemnity Grantor undertake to comply with the instructions, rules and regulations of the Indemnified Persons.

3. Each clause of this deed of indemnity is independent and severable from all other clauses.

4. The acknowledgements, agreements and undertakings in this indemnity shall be deemed to be made in favour of the directors, employees, representatives and agents of Lepogo La Thaba, capable of acceptance at any time.

5. Each element of the release from liability and/or indemnity in respect of each cause or activity covered by this release from liability and/or indemnity shall be separate and severable from the other elements.

6. This indemnity shall in all respects be governed by the laws of the Republic of South Africa, and all disputes, actions and other matters arising in connection therewith shall be determined in accordance with such laws.

7. I confirm that I am not suffering from any of the medical conditions that may preclude me from doing any activities.

8. I further acknowledge that I am solely responsible for the equipment used by me.

9. Indemnity under this agreement shall commence during participation in any Lepogo La Thaba activity.
